AT&T INTERNATIONAL VOICE, DATA AND MESSAGING PACKAGE FOR BUSINESS: Eligibility: Available only to business and government customers with a qualified AT&T wireless service agreement (**Business Agreement**) and only for Corporate Responsibility User (**CRU**) lines of service. Compatible phone with domestic postpaid wireless service (voice, text and data) required. Monthly recurring charge applies on a per phone basis. Package will not be prorated if cancelled on or after the effective date. Package cancelled prior to the effective date will not incur the charge. Requires a 2-month minimum term commitment. **Eligible Devices:** smartphones and feature (basic/quick messaging) phones (sold separately). **COUNTRIES:** Includes talk, text and data coverage in over 210 countries listed at att.com/globalcountries (see International Day Pass destinations). Coverage not available in all areas. Countries and rates are subject to change without notice. **Mexico and Canada:** If you have a domestic plan that includes plan usage in Mexico or Canada, usage in these countries will not diminish your International Voice, Data and Messaging Package for Business voice or data allowance or bill your package voice or data overage charges. **VOICE:** For cellular calls dialed and accepted in package countries. Package voice allowance must be used in the billing period provided or will be forfeited. **Voice Overage:** If you use all your package minutes in a billing period, a pay-per-use rate of \$0.25 per minute will apply. **DATA:** Actual data speeds vary by device and location. If your domestic plan includes Video Management feature, or reduces video streaming speed, the same will apply to your International Voice, Data and Messaging Package for Business. Monthly data allowance must be used in the billing period provided or will be forfeited. **Data Overage:** If you use all your package data in a billing period, we'll automatically add more data at \$25 per GB, which must be used in the billing period provided or will be forfeited. **UNLIMITED MESSAGING:** Package applies only to text and picture/video messages (AT&T Short Messaging Service (SMS) and Multimedia Messaging Service (MMS)) and not to other messaging services/applications. Messages received are charged at domestic messaging rates. **INTERNATIONAL DAY PASS:** For devices with both an active International Voice, Data and Messaging Package for Business and International Day Pass (**IDP**), IDP charges will apply in IDP countries and usage in IDP countries will not diminish your International Voice, Data and Messaging Package for Business data or voice allowance. If you prefer to use your International Voice, Data and Messaging Package for Business in an IDP country, you must remove IDP. **PAY-PER-USE RATES:** Apply when package expires, when traveling in countries and locations not included in your International Voice, Data and Messaging Package for Business, and/or when you have not added a package. For current rates, see att.com/intlpprates. **Cruise Ships/Airlines:** International use aboard cruise ships and airlines is not included. If you use your phone in such locations and do not add an appropriate international package, international pay-per-use rates will apply to all on board usage. **MISCELLANEOUS:** May not be combined with AT&T Business Passport or select other international packages.
